### **I69 FROM THE NORTH - TO FAIRGROUNDS**

CONTINUE ON 169 UNTIL IT TURNS INTO BINFORD BLVD

CONTINUE ON BINFORD BLVD UNTIL IT TURNS INTO E FALL CREEK PARKWAY NORTH DRIVE

CONTINUE ON FALL CREEK PARKWAY AND TURN RIGHT (WEST) INTO STATE FAIRGROUNDS GATE 6 FOR CHECK IN & ENTRY

## 170 FROM THE EAST – TO FAIRGROUNDS

CONTINUE ON 170 TOWARD DOWNTOWN INDIANAPOLIS AND TAKE KEYSTONE/RURAL EXIT #85

TURN RIGHT (NORTH) ONTO KEYSTONE WAY WHICH TURNS INTO N KEYSTONE AVENUE

CONTINUE ON N KEYSTONE AVENUE AND TURN LEFT (WEST) ONTO 38<sup>TH</sup> STREET

CONTINUE ON 38<sup>TH</sup> STREET AND TURN RIGHT (NORTH EAST) ONTO FALL CREEK PARKWAY

CONTINUE ON FALL CREEK PARKWAY AND TURN LEFT INTO STATE FAIRGROUNDS GATE 6 FOR CHECK IN & ENTRY

#### 174 FROM THE EAST – TO FAIRGROUNDS

TURN RIGHT (NORTH) AT EXIT #94 ONTO 1465

**CONTINUE ON 1465 AND TAKE THE WEST 170 EXIT** 

CONTINUE ON 170 TOWARD DOWNTOWN INDIANAPOLIS AND TAKE KEYSTONE/RURAL EXIT #85

TURN RIGHT (NORTH) ONTO KEYSTONE WAY WHICH TURNS INTO N KEYSTONE AVENUE

CONTINUE ON N KEYSTONE AVENUE AND TURN LEFT (WEST) ONTO 38<sup>TH</sup> STREET

CONTINUE ON 38<sup>TH</sup> STREET AND TURN RIGHT (NORTH EAST) ONTO FALL CREEK PARKWAY

CONTINUE ON FALL CREEK PARKWAY AND TURN LEFT INTO STATE FAIRGROUNDS GATE 6 FOR CHECK IN & ENTRY

### **I65 FROM THE SOUTH – TO FAIRGROUNDS**

CONTINUE ON 165 TOWARD DOWNTOWN INDIANAPOLIS

170 AND 165 WILL MERGE AND FOLLOW THE EAST 170 ROUTE

**CONTINUE ON MERGED 170/165 (HEADING NORTH)** 

170 AND 165 WILL SPLIT AND FOLLOW THE EAST 170 ROUTE TURNING RIGHT (HEADING EAST)

CONTINUE ON 170 AND TAKE KEYSTONE/RURAL EXIT #85

TURN RIGHT (NORTH) ONTO KEYSTONE WAY WHICH TURNS INTO N KEYSTONE AVENUE

CONTINUE ON N KEYSTONE AVENUE AND TURN LEFT (WEST) ONTO 38<sup>TH</sup> STREET

CONTINUE ON 38<sup>TH</sup> STREET AND TURN RIGHT (NORTH EAST) ONTO FALL CREEK PARKWAY

CONTINUE ON FALL CREEK PARKWAY AND TURN LEFT INTO STATE FAIRGROUNDS GATE 6 FOR CHECK IN & ENTRY

#### 170 FROM THE WEST – TO FAIRGROUNDS

CONTINUE ON 170 TOWARD DOWNTOWN INDIANAPOLIS

170 AND 165 WILL MERGE AND FOLLOW THE EAST 170 ROUTE

**CONTINUE ON MERGED 170/165 (HEADING NORTH)** 

170 AND 165 WILL SPLIT AND FOLLOW THE EAST 170 ROUTE TURNING RIGHT (HEADING EAST)

CONTINUE ON 170 AND TAKE KEYSTONE/RURAL EXIT #85

TURN RIGHT (NORTH) ONTO KEYSTONE WAY WHICH TURNS INTO N KEYSTONE AVENUE

CONTINUE ON N KEYSTONE AVENUE AND TURN LEFT (WEST) ONTO 38<sup>TH</sup> STREET

CONTINUE ON 38<sup>TH</sup> STREET AND TURN RIGHT (NORTH EAST) ONTO FALL CREEK PARKWAY

CONTINUE ON FALL CREEK PARKWAY AND TURN LEFT INTO STATE FAIRGROUNDS GATE 6 FOR CHECK IN & ENTRY

## 174 FROM THE WEST – TO FAIRGROUNDS

CONTINUE ON 174 AND TAKE THE NORTHBOUND 1465 EXIT #73

CONTINUE ON 1465 (HEADING NORTH AND THEN EAST) AND TAKE THE KEYSTONE/431 EXIT #33

TURN RIGHT (SOUTH) ONTO N KEYSTONE AVENUE

CONTINUE ON N KEYSTONE AVENUE AND TURN RIGHT (SOUTH WEST) ONTO FALL CREEK PARKWAY

CONTINUE ON FALL CREEK PARKWAR AND TURN RIGHT (WEST) INTO STATE FAIRGROUNDS GATE 6 FOR CHECK IN & ENTRY

#### **I65 FROM THE NORTH – TO FAIRGROUNDS**

CONTINUE ON 165 AND TAKE THE EAST 1865 EXIT#129

CONTINUE ON 1865 AND MERGE ONTO EAST BOUND 1465 AND TAKE THE KEYSTONE/431 EXIT #33

TURN RIGHT (SOUTH) ONTO N KEYSTONE AVENUE

CONTINUE ON N KEYSTONE AVENUE AND TURN RIGHT (SOUTH WEST) ONTO FALL CREEK PARKWAY

CONTINUE ON FALL CREEK PARKWAR AND TURN RIGHT (WEST) INTO STATE FAIRGROUNDS GATE 6 FOR CHECK IN & ENTRY
